5.	Request for a Legal Opinion	
	WHEREAS the Minister of Education issued a ministerial order pursuant to section 478.5 of the <i>Education Act</i> dated November 6, 2020;	
	WHEREAS the order requires the English Montreal School Board (EMSB) to implement numerous corrective measures pertaining to the management and control of the school board;	

WHEREAS the order requires the EMSB to comply with oversight and monitoring measures;

WHEREAS the order provides for the appointment of an "intervenant" designated by the Minister and who will report to him on the implementation of corrective measures until June 30, 2021;

WHEREAS the EMSB represents the English-language minority rights holders protected by section 23 of the *Canadian Charter of Rights and Freedoms* and exercises their powers of management and control in education;

IT WAS MOVED BY MR. J. KROMIDA AND UNIMOUSLY RESOLVED THAT the EMSB mandate Power Law to provide a legal opinion on the validity of the ministerial order under the *Education Act*, the *Charter* or any other applicable law.

IT WAS FURTHER RESOLVED THAT Power Law may retain the services of Miller Thomson to obtain legal advice on behalf of the EMSB where needed.
