# 1. <u>Land Acknowledgement</u>

The Chair acknowledged that the English Montreal School Board is located on the traditional ancestral and unceded territory of the Kanien'kehá:ka. We are grateful to live, learn, and work in Tiohtià:ke which has long been a site of meeting and exchange for many First Nations and is currently home to diverse groups of indigenous and other peoples. As a School Board, it is important that we acknowledge the historic and ongoing role of educational institutions in perpetuating injustices against indigenous communities. We are committed to educating staff and students about the true history and current realities of the indigenous peoples of what we now call Canada. Celebrating the cultures contributions and knowledge of the many First Nations Inuit and Métis communities, listening to and amplifying indigenous voices and partnering with local indigenous community members. We offer this acknowledgement as a first step and public commitment to our ongoing process towards reconciliation and justice for indigenous peoples and communities.

# 5. Chair's Report

Presented by the Chair, Mr. Joe Ortona:

> Several of our schools did a fantastic job raising money for the Terry Fox Foundation. We saw our schools being promoted on social media and the events, walking and running to raise these funds. Congratulations go out to all of the schools that were involved in this event;

- September 30<sup>th</sup> was the National Day for Truth and Reconciliation. Many events were held throughout the EMSB to acknowledge truth and reconciliation and to remember the errors of the past and to find a pathway forward. Events were also held to teach students and make them aware of some of Canada's unfortunate history and past;
- The Chair met with Alejandra Zaga Mendez, the second opposition group critic for relations with English-speaking Quebecers, to discuss issues affecting the English-speaking community. The Chair also spoke to Ms. Mendez about the many children awaiting their certificates of eligibility, of which there were 450 across the province, an issue that is truly unfortunate, Ministry's great reluctance to issue certificates of eligibility to students on humanitarian grounds even when they have the documented evidence supporting that it is in the child's interest to be granted English eligibility. They also conversed in general about education, the state of our buildings and the funding received by the Government for our buildings, with regards to transportation, etc. Ms. Mendez was very receptive and suggested that any public statement and press release that is made by the EMSB or QESBA, that they are forwarded directly to the education critics and critics responsible for relations with English-speaking Quebecers so they can be informed. They also spoke briefly about the recently appealed Bill 40 and Bill 96. There were some issues regarding Bill 96 that they did not both agree on, however there were some issues that were acknowledged, that were problematic with regards to English language School Boards.
- The Chair put out an op-ed piece in the Montreal Gazette in the month of September asking the Government to work with the English School Boards and to focus on student success and not legal battles. Unfortunately, the Government didn't heed to this call and they decided to appeal all of the judgement of Bill 40 that was rendered;
- ➤ On the anniversary of 9/11, we remembered all those who lost their lives and the heroes who made the ultimate sacrifice on that terrible day. As we do every year, students across the youth sector, none of whom were born when 9/11 occurred, learned about 9/11 and honored the victims in their respective classrooms;
- Thanks to a generous donation from the employees of SAP Montreal, students from St. Gabriel School were given school supplies that they needed to begin the school year on the right foot. They were given bags containing lunch boxes, water bottles, reusable utensils, markers, pencils, 6 notebooks, etc;
- Throughout several of our EMSB schools, open houses are taking place. If anyone is interested in enrolling their children in our Elementary Schools or High Schools, it's a great opportunity. On our website, there is a whole section dedicated to open houses where all information regarding when and where the open houses will be taking place. If anyone is not available on any of the dates, parents and student will have the opportunity to visit schools by appointment. Appointments can be made by contacting the school directly;
- ➤ QESBA's Annual General Assembly will take place on October 21<sup>st</sup>. Mr. Ortona encouraged all Commissioners to attend either in person or virtually;
- The Government filed an appeal on the entire judgment of Bill 40. The decision of this appeal is very disappointing however it is part of the legal process, they have the right to exhaust an appeal process. Mr. Ortona maintains his confidence that there will be success in the hearing at the Court of Appeal of Quebec. Unfortunately, the Government did not heed to the Bill 40 decision and seems to want to go ahead with adopting Bill 23, and having it apply to the English sector as well. The QESBA is monitoring the situation very closely and will keep everyone informed as to any developments in that regard. If Bill 23 is adopted as is, it is clearly a violation, an infringement of our Section 23 rights and would be ready to go to court;
- PQESBA put out several statements, one of which was expressing a concern with the way that the Government is trying to negotiate with QPAT. They are not respecting the local authorities ability to negotiate. The Government made a list of demands that they want our employees to give up and this is another centralization power that they want to exercise and we've let them know that what they are doing is not respecting Bill 37. A second statement was put out about the deploring situation, that very close to the September 30<sup>th</sup>, cutoff deadline, 450 children, hundreds of which are soon to be EMSB students, are sitting at home waiting for a certificate of eligibility across Quebec. It was stated that this situation is unacceptable and that any student registered after September 30<sup>th</sup>, we will not receive the funding by the Government of Quebec to provide them with the services they need, nevertheless we are expected and will provide them with all of the services. The Government should do its job to ensure that these certificates are processed in a timely manner.

### 6. <u>Director General's Report</u>

Presented by the Director General, Mr. Nicholas Katalifos:

- More than 2000 Secondary students will attend the 23<sup>rd</sup> Annual English Montreal School Board Career Fair on Wednesday, October 25<sup>th</sup> and on Thursday, October 26<sup>th</sup> at the St. Pius X Career Centre. Several on-air personalities from the media will be on hand to talk to students about careers and to serve as guest MC's from 6:00 p.m. to 8:00 p.m. on October 25<sup>th</sup>. The Education and Career Fair will be open to the community at large. This is a great opportunity for parents to attend with their children, Grades 9, 10 and 11, as they look towards post-secondary education options and a one-stop shopping experience. There is no charge and parking is free. The program will be coordinated by the Student Services and Adult Education and Vocational Services Departments of the EMSB. The main objective is to provide students with an in-dept exposure to the various educational opportunities available to them. All students will take part in a brief general information session in the St. Pius X auditorium. Students will then have the chance to visit the various exhibition information booths staffed by reps from the English Vocational Centres, Cegeps, Universities and some private Business Colleges. We look forward to this event and a big thank you to everyone working very hard to make it a success;
- Media Literacy Week is an annual event promoting digital media literacy across Canada. Take place each October, schools, libraries, museums and community groups organize events and activities throughout the week. Media Literacy Week takes place during the week of October 23<sup>rd</sup> to the 27<sup>th</sup>, and this year Digital Citizen Day is coming back on October 25<sup>th</sup>. Organizers invite schools to join them to encourage everyone in Canada to spread positivity online;
- ➤ The EMSB Marketing and Communications Department will be represented at the Annual Canadian Association of Communicators in Education. The conference is taking place in Montreal on October 27<sup>th</sup> to the 29<sup>th</sup>. The program gathers communications professionals from the education fields from across the country. Our team led by Mike Cohen will be present;
- ➤ The EMSB is also thrilled to welcome EMSB alumni and former City News Montreal journalist, Pamela Pagano to our Marketing and Communications team. Pamela's primary role is to work with students at Pierre de Coubertin, Dante and Honoré Mercier Elementary Schools to enhance their media literacy via unique projects such as podcasts, package video reports and more. Pamela will also have the opportunity to highlight other events and activities at these schools throughout the East End. Pamela attended the former General Vanier Elementary School and Laurier Macdonald High School of the EMSB and we welcome her back;
- Mr. Katalifos congratulated all of our schools and centres for their participation in the National Day for Truth and Reconciliation. Schools held Orange Shirt Day activities, commemorations, and field trips to mark the occasion. Parents who would like to view some of the activities that took place can visit the individual schools' websites and social media pages;
- The Fall edition of the EMSB Express Newspaper has been published. It includes an overview of High School open houses, messages from several people of the School Board including our Chair, the Youth Sector Calendar. A special section recognizing volunteers and other sections on gifted and exceptional learners, sports and more. It can be read on our EMSB website and hard copies have been sent out to all schools;
- ➤ The EMSB will have an information table at the Annual Quebec Provincial Association of Teachers (QPAT) on October 10<sup>th</sup> and 11<sup>th</sup> at the Bonaventure Hotel;
- A team from the Shadd Health and Business Centre took part in the BDO Cedars CanSupport Dragon Boat Race on Saturday, September 9<sup>th</sup> at the Promenade Pere-Marquette in Lachine. The Shadd Baton Rouge Fire Breathers paddled their hearts out and collected an outstanding amount of \$15,000. Congratulations to everyone who participated and raised a substantial amount of money for such a good cause;
- Finally, the EMSB will partner with the Skills Compétences Canada organization for a special event on Tuesday, November 7<sup>th</sup>. Students will be invited to participate in hands-on workshops and activities from the various Vocational Training Centres, as well as tour the Rosemount Technology Centre's cabinet making and furniture finishing facilities which are based at the John F. Kennedy Adult Education Centre. The mandate of the Skills Compétences Canada organization is to advance the engagement of youth and their communities in skilled trade and technology careers using a pan-Canadian approach.

## 7b. Mandatory Holocaust Education

**WHEREAS** the Holocaust marked the state-sponsored persecution and mass murder of millions of European Jews, Romani people, the intellectually disabled, political dissidents and homosexuals by the German Nazi regime between 1933 and 1945;

WHEREAS the province of Ontario has introduced mandatory Holocaust learning for the first time in elementary schools this fall;

WHEREAS studies show that when Holocaust education is provided, hate crimes and incidents against Jews decrease significantly;

WHEREAS B'nai Brith Canada states that making Holocaust education mandatory reduces hate incidents targeting other racial and religious minorities;

WHEREAS in 2022, B'nai Brith Canada documented 722 antisemitic incidents in Quebec;

WHEREAS a 2020 survey by Echoes and Reflection, a prominent American program that equips educators for effective instruction of the Holocaust found that those who received Holocaust education are more tolerant and more comfortable with people of a different race or sexual orientation than those who did not;

WHEREAS the EMSB has initiated its own Holocaust Education Program, including guest speakers and visits to the Montreal Holocaust Museum;

**WHEREAS** as Holocaust survivors age and pass away, it is more important than ever that the education system play an increasingly important role;

WHEREAS as the present-day History curriculum in public high schools allows for some opportunities to discuss the Holocaust;

WHEREAS The Foundation for Genocide Education has produced a pedagogical guide entitled "Teaching about Genocide," allowing Quebec teachers to become the first in the country to have access to such an educational tool to support them in the sometimes difficult and challenging task of studying genocides in the classroom.

IT WAS MOVED BY MR. JOE ORTONA, MR. JAMIE FABIAN, MS. ELLIE ISRAEL AND MR. JULIEN FELDMAN AND UNANIMOUSLY RESOLVED THAT the English Montreal School Board call upon Quebec's Ministry of Education to make Holocaust Education compulsory in elementary and high schools and that the Ministry consults the Ontario curriculum and mandate the Conseil Supérieur de l'Éducation and other stakeholders to determine how best to introduce this new curriculum and ensure teacher training.

### 17. Committee Reports

# 17.1 ACSES (Advisory Committee on Special Education Services)

Item presented by Parent Commissioner, Ms. Rosemarie Federico:

- Elections were held at the first meeting of the year;
- The Committee then selected the various topics for this year for which they want presentations in the aim of having a better understanding of certain procedures and protocols in order to be equipped to answer any questions coming from parents. The various topics include:
  - A run through on the journey from the time a child is suspected of having a challenge to being assessed, to receiving a code, to the creation of the IEP and so forth;
  - Resource allocation and how it is determined, who gets assessed first, who gets a laptop, etc;
  - How to obtain a French exemption for those students with a language disability without which the student will not receive their High School diploma and therefore will not be able to pursue higher level education. Furthermore, it has come to the attention of the Committee that if the exemption is successfully acquired, it does not follow the student into Cegep. Despite the fact that the language disability will not disappear upon entry into Cegep the student will have no choice but to be subjected to the requirements imposed by Bill 96;
- Finally last year, the Students Services Department and the parents of ACSES decided to embark on a joint project called the Parent Toolkit. At the last meeting, discussions were had with respect to how the toolkit will be made available to parents, whether it would be on social media, on a website, etc. Also, how and who will manage and maintain the kit. Ideas were discussed regarding the type of information that will be included.
