	WHEREAS the Material Resources Department proceeded to a public tender for the Water Retention Study in accordance with the regulations respecting certain service contracts of public bodies;
	WHEREAS the tender was closed on January 31, 2023, the Material Resources Department received one (1) electronic service offer on the closing date and the service offer received was opened at the appointed time;
	WHEREAS in accordance with the regulations respecting certain service contracts of public bodies, the EMSB must establish a Selection Committee as per Article 43 - Chapter V to evaluate the service offers received for the qualification section of the public call for tenders;
	WHEREAS the Selection Committee met on February 17, 2023 to evaluate the sole (1) service offer received;
	WHEREAS the Selection Committee recommended the sole engineering firm, meeting the requirements of the notice of qualification documentation;
	WHEREAS in accordance with the regulations on certain service contracts of public bodies under chapter C-65.1, Article 23, professional fees are determined in accordance with the respective governmental decrees for professional services provided to the Government of Quebec by architects and engineers (C-65-1 r9 & r12);

	WHEREAS it is estimated that the annual purchase cost of new computer devices and monitors is of \$1,350,000.00, before taxes, totaling an amount of \$6,750,000.00 (before taxes), for the term of 5 years;
