At the Special Board meeting held on June 26, 2019 the Council of Commissioners approved a Major School Change Consultation (Resolution # 19-06-26-6) to evaluate how best to organize and consolidate its school populations and buildings in the north east end of the EMSB territory.

The following are the schools identified in the scenarios:

Please note that the proposed scenarios regarding General Vanier School and John Paul 1 High School were adopted BEFORE the CAQ Government announced publicly, on June 27, 2019, the adoption of two decrees the day before, transferring the buildings of General Vanier School and John Paul 1 High School to the Commission scolaire de la Pointe-de-l'Île. As such, the documentation for the Major School Change Consultation was amended to indicate which scenarios are no longer applicable in light of the said decrees. However, the other scenarios still remain for the purpose of consultation.

The Board welcomes any comments and recommendations regarding the scenarios outlined in the Major School Change documentation during this consultation process. If you would like to submit any comments or recommendations, please forward your brief on this subject via email to longrangeplanning@emsb.qc.ca by no later than **Monday, December 16, 2019 at noon.**

Following the receipt of the briefs, the Council of Commissioners will hold hearings in the evenings of **January 8 and 9, 2020** at the English Montreal School Board, 6000 Fielding. The hearings will give all

consultative partners an opportunity to present their comments and recommendations regarding the proposed scenarios.

The Council of Commissioners will hold a **Special Board meeting on January 15, 2020 (but no later than January 30, 2020)** to make a decision on this subject.
