4.	Proposed Revision of the Administrative Organization Chart 2020-2021 – Adult Education and Vocational Services (AEVS) – For Consultation
	WHEREAS in early 2020, the management firm Deloitte was commissioned to produce an Organizational Review and Action Plan for the Trustee of the English Montreal School Board (EMSB);
	WHEREAS one of the recommendations of this Organizational Review regarding the Adult Education and Vocational Services Department (AEVS) was to "mieux intégrer ce service dans l'organigramme de la commission scolaire, dans le contexte d'une revue plus globale de l'organigramme global" (sic);
	WHEREAS subsequent to the reception of this Organizational Review, the Trustee adopted, on August 31, 2020, a new administrative organizational structure for the EMSB, as per Resolution # 20-08-31-4;
	WHEREAS one of the significant changes to the EMSB structure involved the transfer of ancillary AEVS services, such as human resources, student services, and budgeting to the other departments of the EMSB;
	WHEREAS the Council of Commissioners is preoccupied that this new organizational structure for AEVS may not be appropriate;
	WHEREAS an external consultant, Mr. Ron Silverstone, was mandated by the Interim Director General to "determine if the organizational structure of the EMSB's AEVS Department is best aligned to meet the objectives of the department and those of the school board";
	WHEREAS one of the conclusions of the Silverstone Report is "it is in the best interest of the EMSB to return to the original structure where the AEVS Department does not move personnel to other departments";
	WHEREAS another recommendation of the Silverstone Report is "that the AEVS Director work more closely with the Directors of Finance, Human Resources and Student Services";
	WHEREAS the process of transferring AEVS personnel to other services and departments is underway;
	WHEREAS the EMSB is currently in the process of preparing its 2021-2022 budget and staffing needs;

WHEREAS the Association of English Montreal Board Administrators (AEMBA), the Association Québécoise des Cadres Scolaires – EMSB Section (AQCS) and the Association of Montreal School

Administrators (AMSA) must be consulted on the proposed revision of the Administrative Organization Chart 2020-2021 - AEVS;

WHEREAS the end date for consultation purposed with the aforementioned associations will be THIRTY (30) days following the date of this Board meeting;

IT WAS MOVED BY MR. TONY SPERANZA AND UNANIMOUSLY RESOLVED THAT:

The Council of Commissioners send out a proposal for consultation, to restore the Adult Education and Vocational Services Department (AEVS) to the structure in place prior to the adoption of the new administrative organizational chart 2020-2021, adopted by the Trustee on August 31, 2020.

IT WAS FURTHER RESOLVED THAT the proposed Revision of the Administrative Organization Chart 2020-2021 – AEVS be sent out for consultation to the Association of English Montreal Board Administrators (AEMBA), the *Association Québécoise des Cadres Scolaires* – EMSB Section (AQCS), the Association of Montreal School Administrators (AMSA) and the English Montreal School Board Parents Committee (EMSBPC) and the results of the consultation be returned to Me Nathalie Lauzière, Secretary General, no later than April 26, 2021, in accordance with the documentation submitted at the meeting.

IT WAS STILL FURTHER RESOLVED THAT regardless of the question of the structure of AEVS, and as highlighted in the Deloitte Organizational Review and Action Plan for the Trustee of the English Montreal School Board (EMSB), the Council of Commissioners affirms that AEVS must adhere to the following:

- An adequate, structured accountability processes
- Furnishing appropriate support to international students
- Adequate controls on AEVS partnerships
- Appropriate supervision of the quality of educational services
- Conformity with the rules around procurement and the management of contracts
- Greater collaboration between AEVS and the other departments of the EMSB

IT WAS STILL FURTHER RESOLVED THAT the Council of Commissioners instructs the EMSB Administration to suspend any further personnel and/or budgetary transfers from AEVS to other EMSB departments until such time as the Council makes a decision on the 2020-2021 Administrative Organizational Chart.
