1. Adoption of Agenda

JV proposed that item #8 (Principal Selection Criteria) be moved after varia so he can leave the meeting Moved: MP Seconded: JCP

2. Adoption of Minutes from the GB meeting on November 15, 2021.

EF Requested the following change in wording for her discourse on item #5 re relocation:

EF hopes that parents & teachers (both CSSDM & EMSB) are involved in consultation sooner rather than later

3. Public question period

4. 240 Renewal Application

- JV thanked TS and MEA for their help in finalizing the document for submission. He expressed his appreciation for finding time to help in spite the fact that they were both busy preparing for their December instrumental music concerts.
- The school's 240 status allows us to offer the Fine Arts program, adjusting the teaching time of the subjects to offer more Arts, and allows us to have a selection criteria/admission process for our students. It also allows us to accept students from across the EMSB territory.
- Our 240-status renewal application is due December 17, 2021. The MEQ will review our request for renewal. Our expiry date is actually in one year from now, but the MEQ requires the application to be submitted a year in advance.
- In the application, we have the following sections:
 - Description of the project
 - Criteria for Student Selection
 - Community Impact of the Project
 - Evaluation of the Project
 - o Exam Results and Special Needs
 - Timetables
 - Financial Impacts of the Project

EF asked if there is any power that the GB has to request some flexibility on the timetable or if a case can be made re the number of minutes allocated to the arts vs the academic subjects. JV reminds us that the Minister is strict on the minimum minutes for academic subjects, phys ed etc but MEA argues that in some areas much higher number of minutes than the minimum is allocated.

TS reminds GB that the document was adopted by Staff Council on December 6, 2021. Following the Staff Council's adoption of the document the GB needs to pass 3 resolutions:

o A: Renewal of FACE's 240 Status

Moved: FWB Seconded: JCP – Adopted unanimously

B: Timetables (modified increased time for the Arts)

Moved: EF Seconded: FWB – Adopted unanimously

C: Financial impact

Moved: FWB Seconded: AJG – Adopted unanimously

AJG announced that after the holidays she will no longer have a conflict with the committee's meetings and can resume attending them.

a) Approval Items

1. Sec. 1-2 tubing and skiing February

- a. Joint trip with CSSDM
