# 8. REPORTS

### 8.1 Principal Report

Curriculum night was held virtually on September 9th. Progress Report cards will be available through Mosaik on November 15th followed by Parent/Teacher interviews that will take place virtually on November 18th. Grade 5 and 6 students have been working on an dramatic arts project that takes place once a week with Youth Fusion. Students have been working on a bilingual play to be performed later on in the school year. JCA virtual Open House was held on October 22<sup>nd</sup>, it was a great opportunity to showcase our school.

With this year's Covid 19 restrictions being eased, we were able to have our first fire drill on October 7<sup>th</sup>, students did very well; a lockdown practice will be held later on in the school year as well. CO2 detectors will be installed in all our classrooms by the end of November, as a result of concerns that were raised during the pandemic about indoor air quality in our schools. MDT (Multiple Disciplinary Team) meetings will be held in November, to discuss academics concerns for students at risk with our student services department. Italian PELO classes will be held virtually every Friday evening from 5:30pm-6:30pm. Permission slips for the rapid testing have gone out, however there has been a delay in receiving the kits. The school board released information by email on a Tik Tok Challenge to inform parents and make them aware of the risk of certain media consumption. JCA Virtual Parent workshop will be held on November 4, 2021 with a variety of presentations available to our school community; the event has been opened up to Dunrae Gardens as well. GMAA activities will not be taking place at this time, as two vaccines are required in order for students to travel from school to school.

# 8.2 Teachers Report

Preschool K4 and K5 Teachers attended a Blue Bot workshop on October 14, 2021 where they received training to be used in the classroom with their students. We acquired a school set of Blue Bots to be used in preschool. Benchmark Reading, teachers will be assessing the reading level of students in Cycle 1-3 through reading activities. We have applied for several Culture in the schools grants (Arts and Science) (Granby zoo, Mural artist, Theatre Tortue Berlue and Geordie Production Paperback Princess) where the government subsidies 75% of

the cost of cultural activities. STEAM Curriculum Mapping, Cycle 2 teachers met with the STEAM teacher and board consultants to plan a large scale, cross curricular project where students will incorporate they are learning in social studies into a STEAM project. This years's Halloween activities will include Reptizoo, pumpkin decorating, popcorn and a movie. Reading week will be held the week of December 13<sup>th</sup> and plans are in motion by a committee of teachers.

#### 8.3 Daycare Report

There are 136 students registered in daycare. Given that the Quebec government has eased Covid 19 restrictions, we are now able to offer afterschool activities to our students. October 18, 2021 to December 6, 2021 Grade 4-5-6 Monday: Everblast Grade 2-3 Wednesday: Funky Feet dance For the upcoming Ped. Days in November are activities will include: Sheltoons, Mad Science, and Dynamix. Fieldtrips will be revisited
