 An addendum has been added to the 2023-2024 student calendars, which reflects the collective agreement requirement that teachers select the content for 10% of ped days: As per clause 8-5.03 of the Collective Agreement 2020-2023, two of the moveable pedagogical days, of which the content is determined by the teachers shall be established at the school level.

Subject to the terms and conditions prescribed in the local provisions, at least 10% of the pedagogical days of which the content is determined by the teachers shall be identified by the board when establishing the school calendar as prescribed under clause 8-5.02.

The content of other pedagogical days shall be submitted for consultation to the board-level or school-level participating body of teachers according to the terms and conditions set out in Chapter 4-0.00.
