1. Call to order at 19h01

2. Adoption of Agenda

19h02 Christi motioned to adopt the Agenda, seconded by Evelyn. Motion unanimous.

3. Approval of Minutes

4. Business Arising from the Minutes

- 4.1 Please especially take note of pages 9 and 10 of the GB handbook for some critical information.
- 4.2 Sandra proposes that we change this to "The green committee at this time is Shannon"

Shannon is here to provide details on where the school is at concerning the environmentally focused projects. She mentioned additional hydroponic growing towers, tulip planting on the chabot side of the school, landscape cleanup in collaboration with JFK high school, and upcoming compost education, in addition to many other smaller projects in the school.

Shannon would like to propose a "tulip fundraiser" wherein grade 5 and 6 students would create promotional material and operate sales for tulip bulbs sold by the box. Profits for the fundraiser, potentially up to \$1300.00 would be used to finance further "green" projects around the school.

19h38 motion to approve a tulip bulb fundraiser to benefit the green committee in the week of Tuesday October 10, 11, 12 to be run by daycare and daycare students from 14h35 to 17h30. Motioned by Darcy and seconded by Christi, motion passed unanimously.

5.1 Pedestrian Safety and crosswalks- 19h40 to 20h10 - A very in-depth discussion was started by Geoff on the subject of the crosswalk located at Belanger and Cartier. Principally, he noted the various reasons why the intersection should be considered dangerous and worthy of our attention. Many governing board members voiced their concerns as well and many ideas were proposed, including most notably the value in presenting an organized front of concerned citizens to the city council in order to increase awareness and attract an intervention by city planners. Tanya agreed to bring the issue up with the commissioner as well as sending out an email to parents to begin the process.

- 7.3 Treasurers Report \$898.36 remains in the account from last year. \$1148.36 is the new balance after adding this years \$250.00 allocation.
- 7.4 Principals Report report by Tanya. 2 fire drills have been completed and 2 more remain. 324 students were counted in the school on attestation day, which is slightly less than last year. First month has gone by fast. Photo Day is coming up. Terry Fox Run brought in \$714.
- 7.5 Teachers' Report Melinda provides comments on the "meet the teacher" night, looking forward to many interesting activities this fall. Optimism abounds. Carissa echos that the fun day was a great success. She asks for funding for a student that is not able to attend the Arbraska activity for financial reasons. The motion to use Governing Board funds to cover the cost for this one student for \$25.75 is Motioned by Mark. Seconded by Nadia. The motion is carried unanimously. Nadia continues the teachers' report by relating the fact that milk is now being made available to students if they so desire. Hoop Dancer for Grades 4 6 for Orange T-shirt Day organized by the Spiritual Animator.
