health care services to individuals in Ontario.

THIS COURT ORDERS and directs that the Respondent refrain from using the 4. title "dentist" or "dental surgeon" or a variation or abbreviation thereof, including "DDS".

THIS COURT ORDERS and directs that the Respondent pay the costs of the 5.
