ORDER

THIS APPLICATION, made by the Royal College of Dental Surgeons of Ontario for an Order directing the Respondent, Sergey Kolomeytsev, to refrain from performing controlled acts that constitute the practice of dentistry, from holding himself out as a dentist or dental surgeon, and from using the title "doctor", "dentist", "dental surgeon" or a variation or abbreviation thereof, including "DDS", in the course of providing or offering to provide health care in Ontario, was heard this day.

ON READING the Application Record and upon consent of the parties, filed:

- THIS COURT ORDERS and directs that the Respondent refrain from the practice of dentistry in the Province of Ontario and, in particular, refrain from the performance of any "controlled acts" as set out in Paragraphs 2, 5, 8, and 11 of Section 27(2) of the Regulated Health Professions Act, 1991.
- THIS COURT ORDERS and directs that the Respondent refrain from holding himself out as a person who is qualified to practice in Ontario as a dentist or dental surgeon or in any specialty of dentistry.
- 3. **THIS COURT ORDERS** and directs that the Respondent refrain from using the title "doctor", or "dentist", or "dental surgeon" a variation or abbreviation thereof, including "DDS", in the course of providing or offering health care services to individuals in Ontario.
- 4. **THIS COURT ORDERS** that the Respondent forfeit and the Applicant dispose of all materials and equipment seized by the Applicant from the Respondent in connection with its investigation of this matter.
- 5. **THIS COURT ORDERS** that the Respondent remove and dispose of all dental equipment and furnishings from 55 Tuscona Boulevard, Concord, Ontario, (the "premises") and that he permit a representative of the Applicant to attend at the premises to visually verify that the dental equipment and furnishings have been removed.
- 6. **THIS COURT ORDERS** and directs that the Respondent pay the costs of the Applicant in the amount of \$1,500, plus HST, to be paid within 60 days of the date of this Order.
