- 3. THIS COURT ORDERS and directs that the Respondent refrain from using the title "doctor", or a variation or abbreviation thereof, in the course of providing or offering health care services to individuals in Ontario.
- 4. THIS COURT ORDERS and directs that the Respondent refrain from using the title "dentist" or "dental surgeon" or a variation or abbreviation thereof, including "DDS".
- 5. **THIS COURT ORDERS** and directs that the Respondent pay the costs of the Applicant in the amount of \$2,000.00, plus HST.
