**ORDER**

**THIS APPLICATION**, made by the Royal College of Dental Surgeons of Ontario for an Order directing the Respondent, Richard Lawrence Pass, to refrain from performing controlled acts that constitute the practice of dentistry, from holding himself out as a dentist or dental surgeon, and from using the title “doctor”, in the course of providing or offering to provide health care in Ontario, or “dentist”, “dental surgeon” or a variation or abbreviation thereof, including “DDS”.

**ON READING** the Application Record and the Consent of the parties filed;

1. **THIS COURT ORDERS** and directs that the Respondent refrain from the practice of dentistry in the Province of Ontario and, in particular, refrain from the performance of any “controlled acts” as set out in Paragraphs 2, 5, 8, and 11 of Section 27(2) of the *Regulated Professions Act, 1991*.
2. **THIS COURT ORDERS** and directs that the Respondent refrain from holding himself out as a person who is qualified to practice in Ontario as a dentist or dental surgeon or in any specialty of dentistry.
3. **THIS COURT ORDERS** and directs that the Respondent refrain from using the title “doctor”, or a variation or abbreviation thereof, in the course of providing or offering health care services to individuals in Ontario.
4. **THIS COURT ORDERS** and directs that the Respondent refrain from using the title “dentist” or “dental surgeon” or a variation or abbreviation thereof, including “DDS”, in the context of providing or offering health care services in Ontario.
5. **THIS COURT ORDERS** and directs that the Respondent pay the costs of the Applicant in the amount of \$2,500.00, inclusive of HST.
